## Visit by Professor Richard ("Ricky") Revesz

Members of the Academy living in Sydney will be fortunate to have the opportunity of meeting Professor Richard (Ricky) Revesz of New York University Law School, the incoming Director of the American Law Institute, during a short lecturing visit that he will be making to Australia from 24 to 1 April 2014. He will be landing in Sydney on 24 March 2014.

Professor Revesz will be succeeding, as Director of the ALI, Professor Lance Liebman of Columbia University Law School, who has been its Director for fifteen years. Professor Revesz has been Dean of the Law School at NYU for eleven years, finishing last year.

Fellows will be aware that the Academy has concluded a collaborative arrangement with the ALI and it is very opportune that we can meet the incoming Director to discuss in person the various forms that the collaboration between the ALI and the AAL might take.

What is proposed is that as many Fellows as wish to do so meet Professor Revesz in an informal setting over drinks and savouries at Herbert Smith Freehills, Level 34, ANZ Tower, 161 Castlereagh Street, Sydney, starting at 5.00 pm on Monday 24 March 2014. The Academy is indebted to Don Robertson of HSF and his partners for offering to host this event.
