Inaugural Patron's Address by Chief Justice Robert French AC on Tuesday 30 October 2012

Members of the Academy will have received recently a letter from me giving details of this important event in the life of the Academy. The title of the Chief Justice's Address will be 'Judges and the Academy---Dialogue of the Hard of Hearing?'

The address will be delivered in the No 1 Court of the Federal Court of Australia, Level 21, Law Courts Building, Queen's Square, Sydney.

The event will start at 5.30 pm and conclude at 6.30 pm and will be followed by refreshments.

The Chief Justice has provided the following more detailed description of his topic:

'The things that Judges do and that academics do are different in kind. There is nevertheless a 'dialogue' of sorts as Judges refer to academic work and academics review, analyse and criticise the work of the Court and offer syntheses and extrapolate doctrinal developments good and bad. This presentation offers a judicial perspective on the interaction between legal academic writing and the judicial function.'
